Seminar on "Modern Globalization: The Great Convergence"

200 years ago, on April 19 1817, David Ricardo published "On the Principles of Political Economy and Taxation". In his seminal work, Ricardo was the first one to outline the theory of comparative advantage which has ever since become a leading toolkit for economists to explain why countries trade.

The aim of the seminar is discussing key aspects of modern globalization from an economist's point of view. We will try to understand how globalization has evolved over time, what role the progress in information and communication technology (ICT) has played in the past and what impact ICT could potentially have in the future. The seminar will make you aware of ongoing policy discussion and give you an understanding of why the attitude towards globalization has recently become very diverse within and across countries.
